The Minister of Labour hereby gives notice that on 26th November 1964 he made the Fees of Appointed Factory Doctors (No. 2) Order 1964.

This Order determines, subject to any agreement between the Appointed Factory Doctor and the occupier of a factory, the amount of fees payable by occupiers of factories to Appointed Factory Doctors for various services required under the Factories Act 1961. It provides for higher fees than similar Orders of 1962 and 1963 which it replaces.
